Adopt Slogan "Get Mount Vernon Out of Mud"

The Tuesday noon post-luncheon program of the local Lions club consisted of a discussion of the most urgent needs of our town—street improvement. The discussion was lead by A. A. Bauman, former editor of the Hawkeye-Herald. Probably no town of the same size in Iowa, would tolerate similar streets. This seems all the more remarkable when the general character of the town and its disposition to contribute generously to every religious, educational or philanthropic cause is taken into consideration. Mount Vernon has never failed to over subscribe its quota for any drive, whether for local, county, state national or foreign purpose, yet many farmers along our highway are, taking their produce to other towns, because of the condition of our streets. "We can get to town easily enough now, but if we leave main street we are likely to need chains." Streets in Mount Vernon are used much more than most country roads and farmers are beginning to wonder why town people are so much interested in having the other fellow's highway improved when many people in town do not dare venture out of their own garages on account of the town mud. It was the consensus of opinion of the club that the next drive should be a local street improvements, which drive is entirely justified both for the sake of civic pride and financial reasons. Our past road program has cost us too much and we have only mud to show for the money expended. Our slogan should be "Get Mount Vernon out of the Mud."

COMMUNITY CHRISTMAS TREE

Program Will Be Given In Front of the City Hall

Mt. Vernon and surrounding community will celebrate Christmas in a unique way this year. There will be a huge Christmas tree set in front of the city hall and rows of smaller trees uniformly placed in front of all the business houses on both sides of the street throughout the business district. There will be other decorations as the merchants are enthusiastic for the "big community idea". The large tree at the city hall will be brilliantly lighted with varied colored lights each night for the entire holiday season.

A community "sing" around the big tree will be a feature. The evening of December 22 is fixed for the program. All pupils of our public schools and from the country schools surrounding Mt. Vernon will make up the great open-air chorus. The entire community, old and young, is invited to set apart that evening from seven o'clock to eight-thirty for a real community get together time.

A short pilgrimage will follow the song program around the tree. This pilgrimage will take the crowd to several windows of business houses.

Here scenes of the birth of Christ will be portrayed by young people of our own community, in costumes and faces, appropriate to the great central Christmas thought. A full announcement and program will be given in the Hawkeye-Record in the next issue.
